- **Recognition of 2015 EFL Champions:** The league recognized the Syracuse Strong as EFL Champions for 2015; comments were made by Leroy Collins and Chris Gorman
- Approve Minutes of Last Meeting (Officials & Coaches Meeting): Approved via motion from Watertown/second by Plattsburgh
- EFL Treasurer's Report: Motion to approve by Watertown/seconded by Plattsburgh
- **Playoff Game Financial Reports Per EFL Forms:** Discussion of playoff/championship financial reports due to the league. Syracuse requested that the commissioner e-mail forms to Syracuse
- Glove Cities Status; Sussex Loss Claim: Commissioner Burch mentioned that several attempts were made to contact the Capanos with no response via email, text and priority mail. They have been requested to submit their intentions for their franchise in writing to the league. At this moment they are not in good standing with the Empire Football League. Sussex filed a loss claim against Glove Cities for the forfeited games. This will be resolved at a later date when Glove Cities appears before the league.

Review EFL All Star Selections (Rick Sager): Not all teams returned their ballots prior to the meeting, but were completed on site during the meeting. Rick will compile the results and will send out prior to noon on Monday (Oct 12th). It should be noted that Glove Cities did not submit any nominations for their team.

New Business

Discussion Process for EFL Potential New Member Team Candidates per Handout: Unlike last year, all league fees will be due from new teams at the annual meeting in January 2016. Because of the abuse of the agreed to process last year, Commissioner Burch stated that teams will be invited to the Annual Meeting based on meeting application criteria. Fees will be collected at this time per our previous precedent and the By Laws. Teams need to inform their board regarding the EFL's process in this regard. All teams present reinforced that they were committed to the EFL for 2016.

- If you have teams that are interested in the EFL, they are to contact the EFL Commissioner, Dave Burch for application/invitation to the annual meeting.
- Please advise your organizations accordingly; this is being done to short circuit the misrepresentations that occur each year around this time. (see attachment below from 2015).
- Information regarding who is invited to the annual meeting and potential teams per the chart above will be formally communicated to all EFL members simultaneously; there is no longer any need for phone calls to league management to see who has paid their dues or who is being invited to the annual meeting.
- If the new teams do not materialize and the EFL ends up with only 4 teams for 2016, the league is prepared to take a leave of absence for the 2016 season, just as we were prepared to do at the 2015 Annual Meeting and just as we have done previously.
- The EFL Annual Meeting/Location January 30th 31st: Annual Meeting will be held January 30th 31st, 2016 in Binghamton, NY at same location as last year (Doubletree).
- Miscellaneous: Because of the blatant misrepresentations that continue to take place regarding the EFL and its management, Commisioner Burch stated that he plans to use Social Media postings/Press Releases to get the facts in front of the public as required, to allow them to be better informed. EFL members are advised to inform their boards and team management regarding this policy, and also share the EFL's meeting minutes with their organizations since they are publically available on the website. It's our collective responsibility to ensure the structure/integrity to protect the league.
- Any by law changes must be submitted to Commissioner Burch in writing, no later than January 1, 2016, for discussion at the annual meeting. One topic for discussion will be the tie breakers.
